Legal Business Name accuracy is crucial.

i.e., spelling, punctuation, capitalization & spacing

If in doubt, match PECOS verbatim.

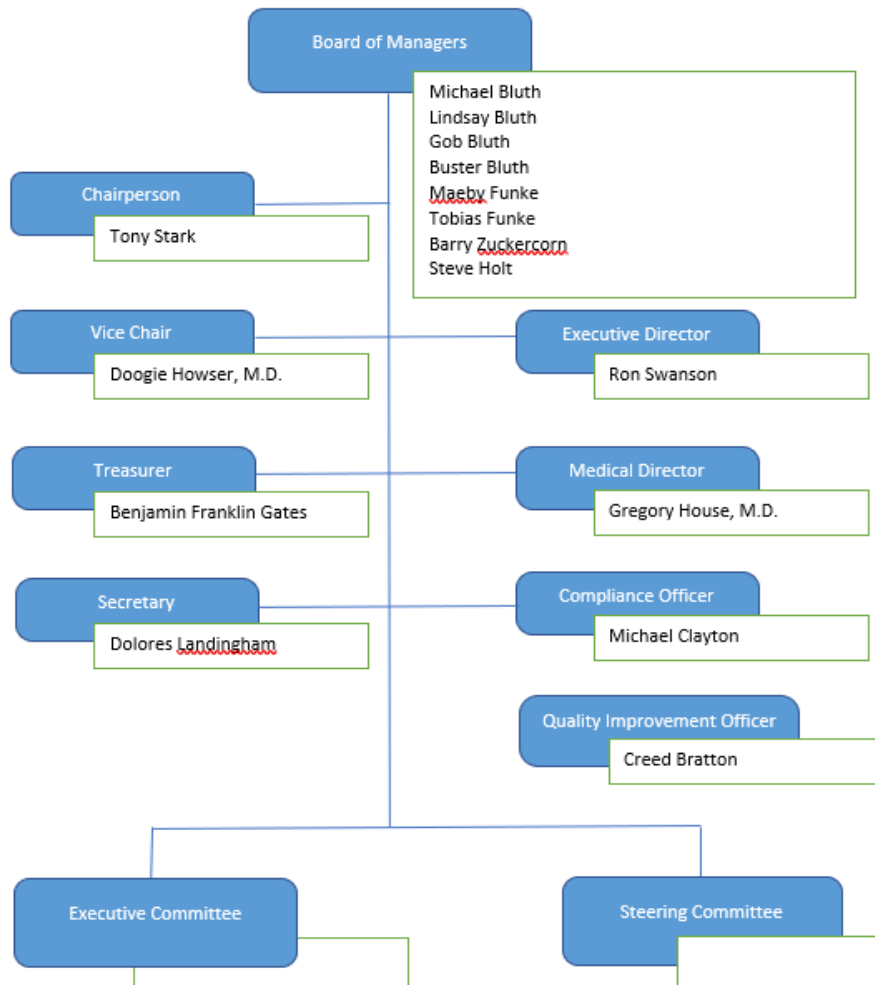
Banking Information

Confirm Providers

Thoroughly review your ACO provider/supplier list, even after participants are formally approved

Merged/Acquired TINs

Verify you have appropriate documentation to submit to CMS

10

Clear & Valid Execution

- E-signature is OK, if done with reputable vendor.
- Inserting scanned copies of a signature is not.
- Ensure proper signing authority

11

Engage CMS
